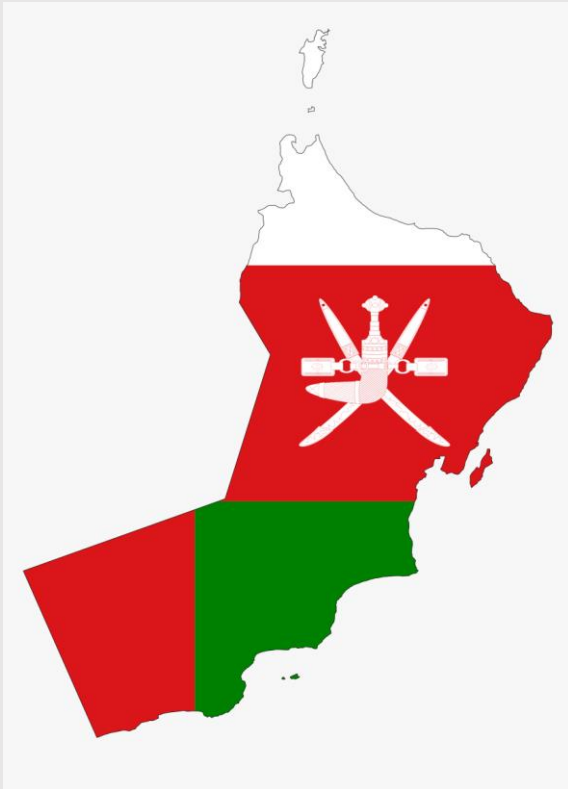

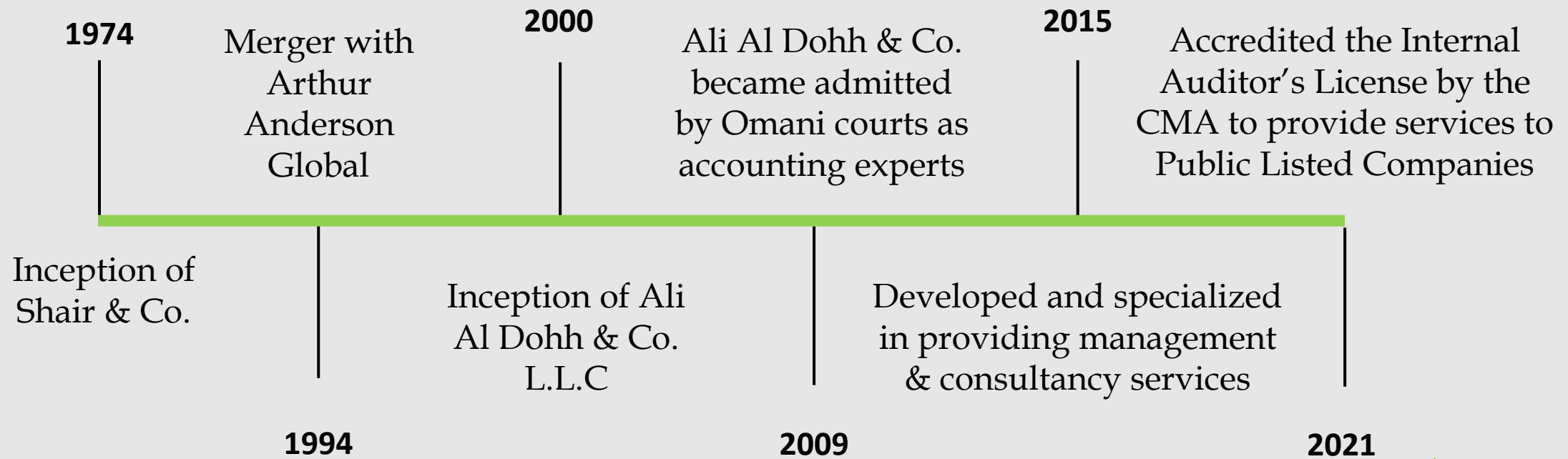


Company History

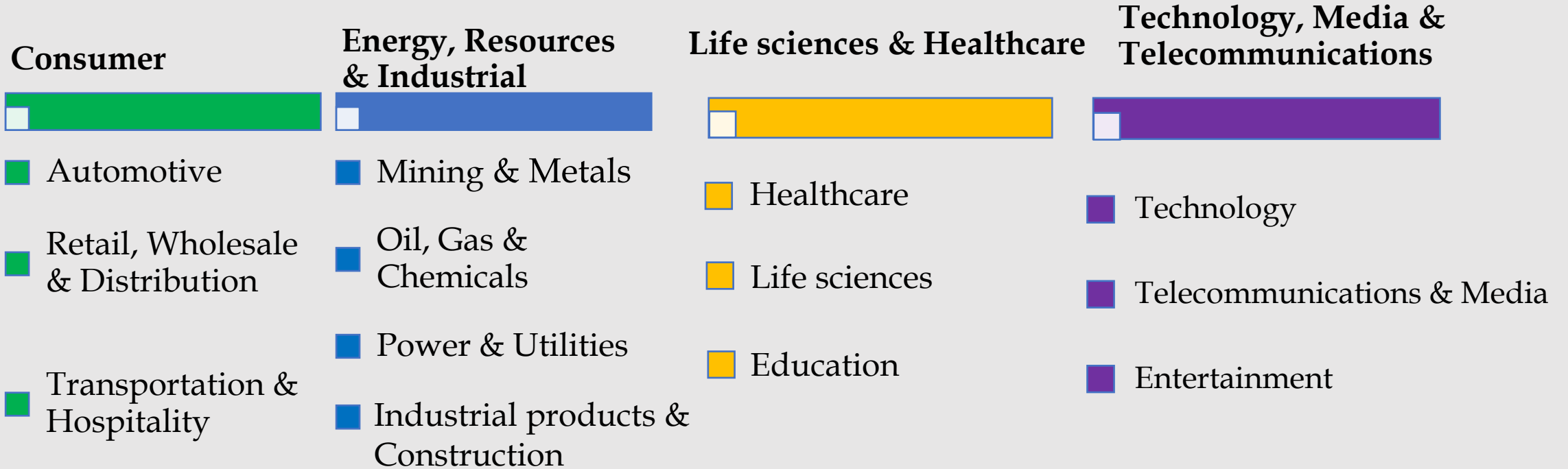
